Thanks for your email. I believe that we should probably discuss this a little prior to your arrival. The drill training site has been moved to an indoor facility (an old hamlet garage) and the water that it uses is supplied by our hamlet water trucks through a tank. The drill operates within the hamlet and is coordinated by the hamlet so I would think that it should come under that license. Last year we supplied water over an 8 week period and this year we have one course planned which equates to supplying water for four weeks.

Originally this was set up outside and operated independently drawing water from a small pond but that ended about two years ago if my memory is correct!
