Good afternoon,

I apologize for the delay in getting back to you, but we wanted to be as detailed as possible with the answer before replying.

I would like to clarify the mention of water for dust suppression during the road construction. Given that traffic on the road will not be significant, and provisions in the forthcoming Environmental Protection Plan will be made for appropriate speed limits, the proponent is not anticipating much of a need for dust suppression via application of water. The construction will be monitored visually for dust generation and should the need arise, water for dust suppression purposes will be supplied by the Hamlet of Sanikiluaq water truck. The proponent is currently working to confirm availability with the Hamlet before advising the construction contractor.

The only other consumptive need for water in this phase of the construction will be for preparation of grout. Grout is required for installation of the rock anchors that are a part of the turbine foundation. The proponent anticipates requiring 5 cubic metres of water at most. The current plan is to purchase the water from the Hamlet.

On behalf of Nunavut Nukkiksautit Corporation (NNC), I would like to submit an application for a water license for the Anuriqjuak Nukkiksautit Project in Sanikiluaq as proposed by NNC in their NIRB Application (#22XN052).

NNC is seeking to construct a wind energy project just outside of Sanikiluaq, in which an existing trail will be upgraded and extended to provide access to a site for wind turbine construction.
