Subject: Information about the BIPAR Guidelines

Dear Craig,

The following addresses your concern regarding the releasing of the Final Guidelines:

The Board distributed the Draft Guidelines for a period of 6 weeks. This gave participants adequate time to advise the Board of any concerns, comments, inclusions, deletions that they felt were appropriate and to provide commentary/rationale for same. The Board weighed all the evidence from all 20 interventions and was satisfied that they had received appropriate direction from these Parties. The Board's job is to review "evidence" and make a decision. Not all Parties will agree on all of the issues and it is the Board's job to make the final decision.

In sending the guidelines out as a 2nd draft, the Board was not convinced that it would receive additional information but rather more of what it had already heard. The Board stands behind its decision to finalize the guidelines at this time. If however any Party has objections to this they can formally write the Board with their concerns and the Board will review them.

I trust this is satisfactory.

Please also be advised that the following correction needs to be made in both the cover letter and the Final BIPAR guidelines, sent on December 1, 2004.

Where the address of the Hamlet of Kugluktuk says P.O. Box 309, it should say P.O. Box 271.

I hope this has not caused any problems.
