Subject: Renewal and Amendment Application for Water Licence 8BW-CLY0810

Dear Mr. Simon and Mr. Flaherty,

The Nunavut Water Board (NWB or Board) acknowledges receipt on December 13, 2010 of additional information regarding Qikiqtaaluk Corporation's (Licensee) application to renew water licence 8BW-CLY0810 (Application). The additional documentation includes:

- Email from the Acting Senior Administration Officer of Clyde River authorizing disposal of waste in the community's landfill in accordance with Part D Item 3 of water licence 8BW-CLY0810 (Licence);
- As-built drawings of the bridge and crossing 7a in accordance with Part G Item 5 of the Licence and clarification regarding the status of the other crossings;
- Response to the requirements of Part G Item 6 of the Licence; and
- Response to the requirements of Part J Item 4 of the Licence.

The additional information has been uploaded to our ftp site, using the username of "public" and the password of "registry", without the quotes.

Given the additional information provided above and the Record of Conversation between Philippe Simon, the Licensee's representative, and Karlette Tunaley, NWB consultant, dated October 18, 2010, it is the Board's understanding that the Licensee has changed its plans from those originally stated in its renewal application submitted August 2010. The Licensee now plans to complete abandonment and restoration of the road in 2011, leaving the bridge in place.

As such, the Licensee is advised that the proposed change will require a renewal and amendment of the Licence. In addition, the Licensee is advised of Part I Item 5 of the Licence requiring the submission of an Abandonment and Restoration Plan six (6) months prior to the planned decommissioning of the road, bridge, or stream crossings. To date, this plan has not been submitted.

A response to the above requirement is requested from the Licensee as soon as possible in order to proceed with processing the Application for Renewal.
