I noticed that you are currently putting information together for the NIRB, to address their questions regarding the Swan Lake River Bridge Project.

One of the requests which overlaps between the NWB and the NIRB is the requirement for a Spill Contingency Plan; as indicated to you in an email on July 14, 2015. I noticed in your communication with the NIRB that you may be seeking some clarification of what is expected in a Spill Contingency Plan.

Spill Contingency Plans must adhere to the Spill Contingency Planning and Reporting Regulations, which is attached for your convenience. A useful reference document when authoring a Spill Contingency Plan, which also includes a template in the appendix, is AANDC's Guidelines for Spill Contingency Planning, which is also included for your convenience.
