The following works and activities have been proposed in the above-noted project proposal:

1. Construction and maintenance of Contwoyto Winter Road
2. The Applicant wishes to withdraw additional water to support winter road construction. The original application included withdrawal of 49 m³/day of water, to be authorized by the NWB as a Use Without a Licence. The Applicant now wishes to withdraw up to 299 m³/day to be authorized by the NWB under a Type B licence.

4. Location: Kitikmeot Region; [Contwoyto Winter Road]

The Nunavut Planning Commission (NPC) has completed its review of the above noted project proposal.
