Hi Derek,

I follow up on missing documents for the Water License Application 8BW-PIM. We are processing some of the documents at the moment but here is a status summary for each missing files.

- 1) Spill contingency plan: attached to this email
- 2) Abandonment and Restoration Plan:

At the end of the construction, the specifications ask us to "barricade the haul route with an earth berm to avoid use by vehicles. Handover shall be in useful condition and without potholes". For this reason, no restoration plan is necessary for this project.

- 3) Simplified map of the project : attached to this email

- 4) Culverts description:

On the project 11 culvert or less will be placed depending on the conditions on field. Each one of these culverts will have a 900 mm or 1200 mm depending on the width of the watercourse (to be determine on field). On the attached file "Culvert Location" every culvert is identified on the green road which is the hauling route.
