CIRNAC is satisfied with attached Spill contingency plan.

But CIRNAC would need some clarification for # 4 :

1. The renewal licence is until December 31, 2021.
2. Please see attached the most up-to-date Spill Response Plan (15255-00331-07-TA-GN-CWP-0003-6.pdf).
3. A closure and reclamation plan is going to be submitted by Tower Arctic within 90 days of licence issuance.
4. The Quarry is not part of the Type B Water Licence No. 8BW-PIM1821 and this licence is related to the water crossings along the Haul Road of the Pond Inlet Marine Infrastructure Project. Why Tower Arctic shall provide a Quarry Management Plan and Monitoring Plan?

In the Arctic Tower Ltd dated July 23 2018 **8BW-PIM1821**

Under I. Project Overview

- Quarrying, transport, and deposition of approximately 200,000 tonnes of rock from a new quarry located approximately six (6) kilometres (km) from the Hamlet to Pond Inlet.

There is no mention of Quarrying under the Scope of the licence but under project overview there is mention.

In the licence dated June 30 2015 3BM-PON1012 the Hamlet of Pond Inlet licence

No mention of a Quarry in the licence.

CIRNAC would like clarification of who should be in overview of the Quarry and under which licence it should be under.

And Tower Arctic should still have a monitoring plan regardless
