The original licence, 8BW-PUL0607, contemplated reclamation which would be removal of the bridge, however, the licence expired in September 2007, therefore I believe that the licence needs to be renewed for the bridge removal (site reclamation) to occur or a new licence issued to fulfill Part H of the original licence. Renewal, based on completion next year, would be the easiest (I think)

Part H:

1. *The Licensee shall complete all restoration work prior to the expiry of this Licence.*
2. *The Licensee shall carry out progressive **reclamation of any components of the project no longer required** for the Licensee's operations.*
3. *The Licensee shall remove from the site, any materials and equipment before the expiry of this License.*

Hope that helps. They must provide the Board with the follow-up information as outlined in Part B:

*Part B: 2)iii. A description of **all progressive and or final reclamation** work undertaken, including photographic records of site conditions before, during and after completion of operations.*

I can't find a copy of the licence in INAC's wonderful document management system! I'm gone the rest of the day, but will phone back after work (maybe). David is back, you can talk to him.

It is difficult to tell from the application, however, I believe that it is a Bailey Bridge and should not/does not

encroach into the flood plain, but spans the entire stream (it lasted 5 to 10 years). A licence should be required for the construction (they will be working in the stream) and for the foundations if the foundations encroach into the 1:2 flood plain. No heavy equipment is indicated, so little or no encroachment and armouring of the active stream bed is likely to happen. I would suggest that the Board approve with a requirement for additional information such as: length of the span of the bridge (foundation contact to foundation contact), width of the stream (at time of construction and during normal spring or summer flood), whether the height is above the water or the flood plain and pictures of the foundations for each end of the bridge. As constructed pictures would be adequate.

The community should also indicate the downstream effects if the bridge is washed out &/or fails.
