# RE: NPC File # 149478 [Coastal Surveys of Common Eider Nesting Islands in the Belcher Island Archipelago, Nunavut]

The following works and activities have been proposed in the above-noted project proposal:

1. Scientific Research: Population surveys for common eiders on Belcher Island Archipelago to determine the changes in colony distributions and sizes. This information will also be helpful in informing the planning of a desired Marine Protected Area within the Belcher Islands and Sleeper Islands Archipelago.

- 2. Modifications to the original/amended project proposal: Permit renewal. Field work was not undertaken due to COVID-19.
- 3. Associated NPC File No: 148225, 148512 and 149308; Associated NIRB FILE No: 06AN026.
- 4. Location: Qikiqtani Region (South Baffin); [Belcher Islands, within the community boundaries of Sanikiluaq]

The Nunavut Planning Commission (NPC) has completed its review of the above noted project proposal. The NPC previously reviewed works and activities associated with the current project proposal and a determination was issued on March 5, 2020 (NPC file 149308) that it is outside the area of an applicable regional land use plan.

In addition, works and activities associated with the current proposal were previously screened by the Nunavut Impact Review Board (NIRB FILE NO.: 06AN026).

The above-noted project proposal is exempt from screening by the NIRB because the NPC is of the understanding that the proposed modifications (i.e., extending project end date) do not change the general scope of the original or previously amended project activities, and the exceptions noted in Section 12.4.3 (a) and (b) of the Nunavut Agreement do not apply.
