Hi Richard,

As a follow-up to our conversation, the

Nunavut Water Board (NWB) is currently seeking legal advice on whether it can allow, under the Waters Regulations, existing Type "B" licences to switch to approvals-without-licences prior to all closure and reclamation work being conducted and Type "B" licences cancelled. Once the NWB receives legal opinion on this matter, it will issue a decision on whether Arctic Watch Lodge can received an approval for an authorization to use water and/or deposit waste without a licence.

In the interim, however, if

Arctic Watch Lodge decides to apply to renew its existing Type "B" licence, this may ensure that a permit will in place for Arctic Watch Lodge to continue its operation in the near term. Alternatively, consideration could be given to waiting until the NWB obtains a legal opinion on the matter to determine whether an approval can be granted to Arctic Watch Lodge to use water and/or deposit waste without a licence for its existing project
