Dear Brady,

Many thanks for getting in touch and apologies for the missing details and occasional non-specific language. I've responded to your points here below:

- 1. Block 3: Kivalliq-owned: yes apologies I meant Inuit-owned land here. We have applied for a KIA Exemption Certificate.
- 2. Block 5: I'm afraid it's very difficult for us to predict where exactly we will be camping as we still aren't sure exactly where the main concentrations of caribou will be as you say, we will be reactive to herd movements, and will use our first day to scout the area with the helicopter before choosing where to establish our small mobile camp (3 small tents). We could happily inform the NWB of our camping location as we choose it in early June if that would suffice? We could choose a location in advance for the purpose of this application, but it would almost certainly be changed as we scout the area and choose an appropriate place to site the camp with easy access to the herds while remaining hidden and causing as little disturbance to the herds as possible. Do let me know if I can elaborate further on this I'd be more than happy to.
- 3. Block 13: We've over-estimated on the anticipated water to be extracted daily from local freshwater sources to be on the conservative side but upon requiew I can amend the anticipated extraction figure to 30-40 litres
- 4. Can confirm a YES tick to the last three boxes on the final page
- 5. Many apologies, I have attached an English summary of the project application here

Good afternoon Toby,

I am the technical advisor assigned to your Application. To move forward with your application for an Approval Without a Licence can you please address the following issues:

- Block 3 (Name of the Owner of the Land) states, "Kivalliq Owned". This requires further clarification as Kivalliq is a region of Nunavut. There is crown land, park land, municipal land and Inuit Owned Land in the Kivalliq region. The Inuit Owned Land in Kivalliq is administered by the Kivalliq Inuit Association, which, after reviewing your project extents, is maybe what was meant.

- Block 5 does not detail camp locations. I understand due to the nature of the undertaking BBC's photographers may be very mobile; however, are approximate camp locations available, or will the photographers simply be following wherever the herds travel?
- Block 13 states that less than 30 L of grey and black water will be produced per day. However, Block 11 states that less than 200 L of water will be extracted per day. Normally, water use volume equals grey plus black water volumes. Please elaborate on the discrepancy.
- The boxes on the last page of the Application have not been checked "yes" or "no".
- Lastly, pursuant to section 4 of the Guide to the Approval for the Use of Water or Deposit of Waste Without a Licence, please provide an English version of your project summary. My Inuktituk is a little rusty.
Please contact me with any additional questions or concerns you may have.


