The NWB advises that if you have not already done so, please get in touch with the Commission directly to submit a project proposal and forward the Commission's determination and any associated recommendations to the NWB when received. While the NWB awaits the Commission's direction, the NWB will continue to review the application for completeness and you will be notified in due course of any deficiencies. Once the application is considered complete, the NWB will forward the file to the technical department for review and upon receiving confirmation that the Commission's process is concluded the Board may issue a one year approval.
