I'm new to the Nunavut Water Board (NWB) and have been assigned the review of an approval without Water Licence application for the Cape Bounty Arctic Watershed Observatory (CBAWO) (NPC File No. 148366). The NWB file number for this application is 8WLC-CBA1718.

On the NPC public registry, it looks to me like NPC has reviewed the project on a long term basis 2017 to 2020 (http://npc.strata360.com/portal/project-dashboard.php?appid=148366&sessionid).
