I have previously sought NPC approval for the camp operation (most recently given in 2014, attached) related to my Crown Land Use Permit extension. This land use has not changed and follows the same activities. Most recently my Crown Permit was extended for 2016 (attached).

It is not clear to me if I need to apply for separate NPC conformity, or if this was already sought by AANDC for my Crown Permit extension. Please let me know if you do need me to provide any information.

The Nunavut Water Board Licensing Department acknowledges receipt on January 5, 2016 of your Application for an Approval Without A Licence. Currently the application is being reviewed internally for administrative completeness.

Note: As required by recent changes to Articles 11 and 13 of the Nunavut Land Claims Agreement (NLCA), all project proposals requiring an application to the NWB, such as this, must be submitted to the Nunavut Planning Commission (the Commission) for their consideration and processing under the NLCA before the NWB can approve an application. The NWB advises that if you have not already done so, please get in touch with the Commission directly to submit a project proposal and forward the Commission's determination and any associated recommendations to the NWB when received. While the NWB awaits the Commission's direction, the NWB will continue to review the application for completeness and you will be notified in due course of any deficiencies. Once the application is considered complete, the NWB will forward the file to the technical department for review and upon receiving confirmation that the Commission's process is concluded the Board may issue a one year approval.
