Hello Etienne,

It may be easier to backhaul all solid waste to an approved facility (landfill). If, however, you decide that open burning is the way to go, please be advised that there are guidelines in place to be followed:

- · Government of Nunavut Department of Environment, Environmental Guideline for the Burning and Incineration of Solid Waste, revised January 2012;
- Environment and Climate Change Canada, Open Burning of Garbage Brochure, dated 2010; and
- Canadian Council of Ministers of the Environment, Guidance Document for Canadian Jurisdictions on Open-Air Burning, dated 2016.

As for annual reports, I am attaching last year's approval for your project. For such approvals, the requirement is a bit different than for licences in the sense that you are not required to submit a report if you have another approval or licence for the same project: "The Authorized Entity need not submit the report referred to in Item 8 (c) if the Authorized Entity obtains a new approval authorizing a use of Water or deposit of Waste without a licence, or a licence authorizing a use of Water or deposit of Waste for the same undertaking on the same site within thirty (30) days after the last day of the period previously authorized".

The contents for a report are outlined in the Approval.

To answer the questions:

- 1. about the incineration: we do not have an actual incinerator, it would be something like open burning. The type of things we think about burning are cardboards from boxes and whatever that can be burned easily. The preferred option is to bring back everything and not burn anything on site, like we did last year.
- 2. about 3BC-HIS1313 it was well before my time I think. I will forward your request to my supervisor so he take contact with you to fix the matter.

I tried to find information about how to prepare yearly report on the site for the NWB but to not avail. Could you re-specify the procedures about yearly reporting and also tell me if I am late providing reports to your organization?
