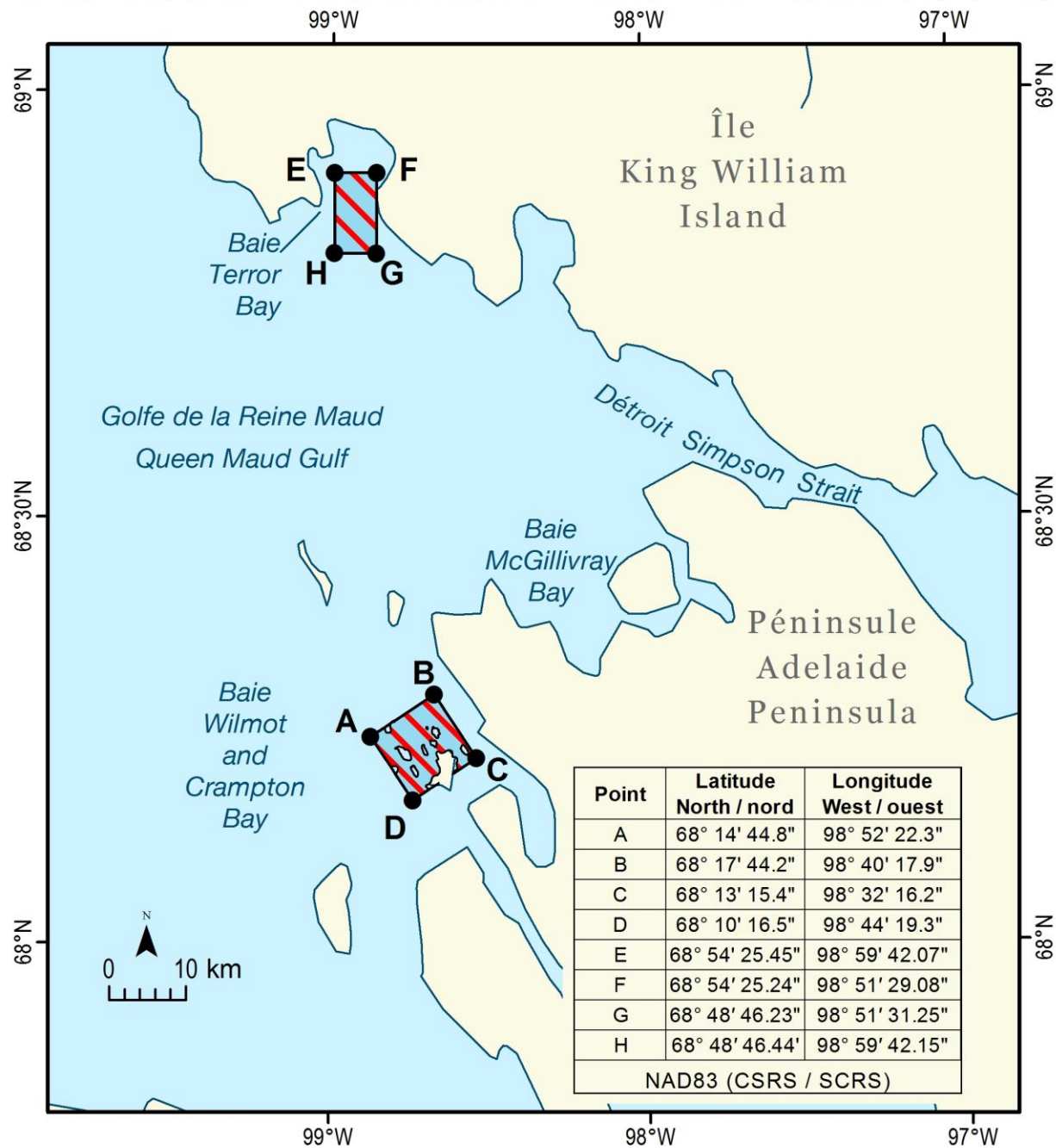
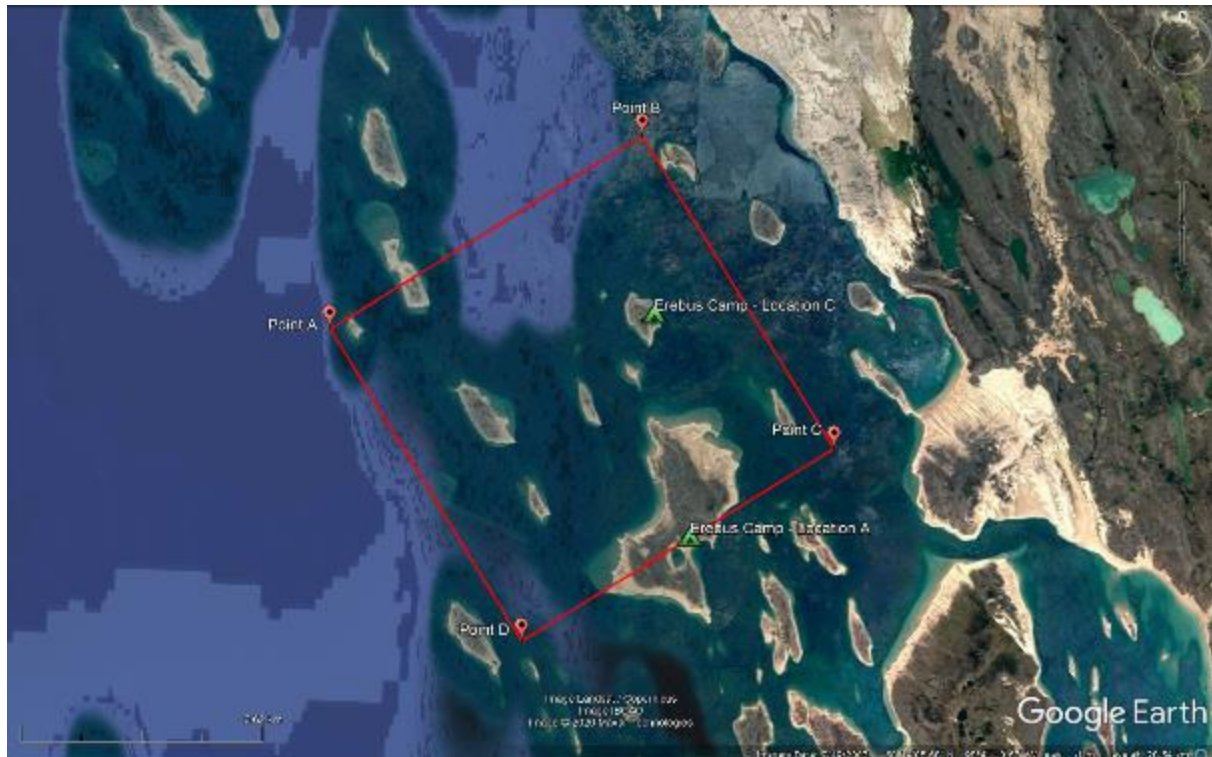


Figure 1. Map from Parks Canada on location of Wrecks of HMS Erebus and HMS Terror National Historic Site

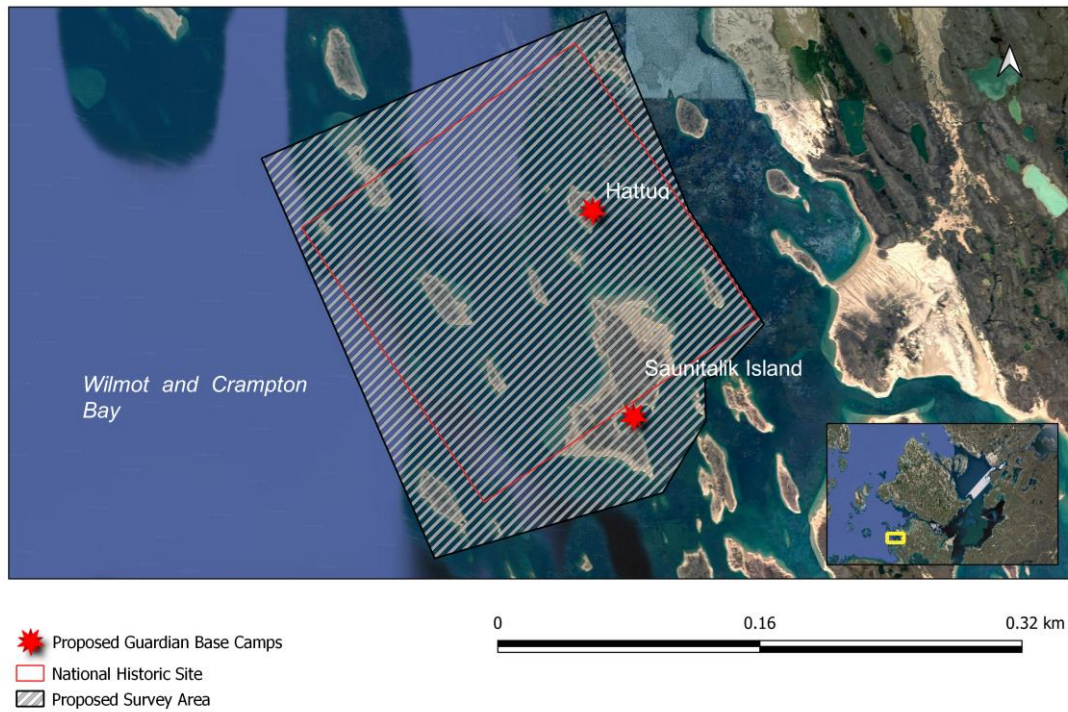


Figure 4. Inuit Heritage Trust terrestrial archaeology survey area and locations by *Erebus* component of national historic site to screen Guardian basecamp locations.

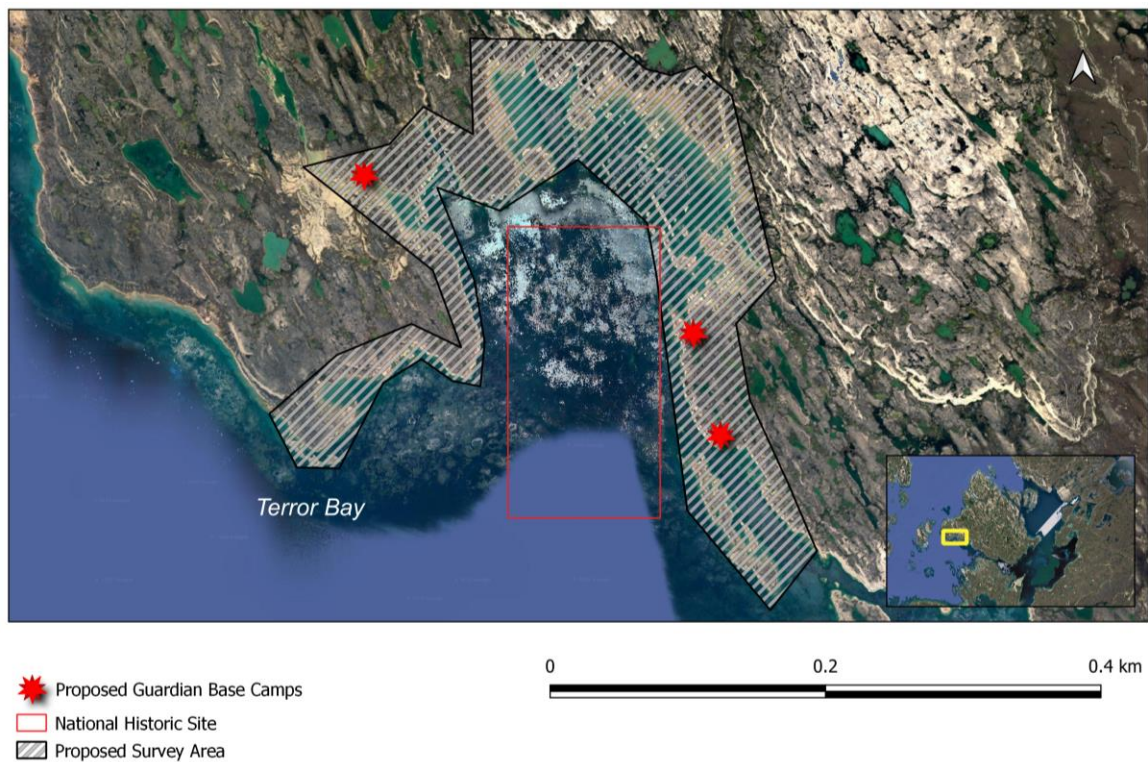


Figure 5. Inuit Heritage Trust terrestrial archaeology survey area and locations by *Terror* component of national historic site to screen Guardian basecamp locations.

Two basecamps will be set up by groups of 4 Inuit Guardians near each of the wrecks of HMS *Erebus* and HMS *Terror* to support site management, and in particular protection and presentation of the sites. Early August basecamps at eastern shore of Terror Bay will be occupied with Inuit Heritage Trust to conduct terrestrial archaeology surveys through their permit to screen area in order to establish permanent cabins for Guardians.

**8. DESCRIPTION OF UNDERTAKING AND EQUIPMENT USED** – Provide a brief description of the undertaking including a description of any equipment that will be used in using water or depositing waste.

- See attached detailed project description for the Inuit Guardian Camps.

- Two remote small temporary camps will be set up for use as Inuit Guardian base camps.
- For human waste, Pacto toilets will be provided; alternately human waste will be deposited into the high tide line.
- Greywater will be deposited on the tundra 31 m away from any water body or else into high tide line.
- Will use locally sourced water, and will gather water for camp purposes using hand containers such as in buckets or jugs, and anticipated emergency portable desalinators for saltwater purification.
- Domestic waste will be collected in containers such as plastic drums and disposed of at approved landfill in Gjoa Haven after the camp season.

I have read and agree to comply with the following conditions outlined in sections 4(3), 5(4), 5(5) and 6 of the Nunavut Waters Regulations:

1. In the case of an applicant who has a mineral right and who intends to use waters or deposit waste in relation to that right, the applicant shall respect the priority conferred on Inuit by section 62 of the *Act* as if that applicant had a licence for the use or deposit.
2. Measures must be taken prior to using water to minimize any alteration to the bed or banks of a watercourse whose waters are to be used, and the measures shall be maintained during the operation of the undertaking.
3. No waste is to be deposited to surface water or within 31 metres of the ordinary high water mark of any body of water.
4. The waste shall not contain more than 15 milligrams per litre of petroleum or petroleum product and must not have a visible hydrocarbon sheen.
5. Prior to the closure or abandonment of the undertaking or end of the period authorized for the use of water or deposit of waste without a licence, whichever occurs first, the site shall be restored — to the extent practicable — to the state in which it was before the water was used or the waste was deposited.<sup>a</sup>
6. An applicant who is authorized under the Regulations to use waters or deposit waste without a licence shall:
  - a. maintain accurate and detailed books and records of:
    - i. the quantity of water, in cubic metres, used each day,
    - ii. the quantity, in cubic metres, of waste deposited each day,
    - iii. the type of waste deposited each day,
    - iv. where the waste is deposited,

- vii. the measures that were taken to avoid or mitigate any adverse impacts of the deposit of waste.
- keep the books and records on the site of the undertaking during the period of its operation and make them available during that period to an inspector on request;
  - submit to the Board a report containing a summary description and supporting photographs of the restoration of the site of the undertaking within 30 days after the earliest of (i) the day on which the undertaking is closed or abandoned, and (ii) the last day of the period authorized for the use or deposit without a licence;" and
  - keep the books and records for two years after submitting the report describing the restoration of the site of the undertaking.

## Notes:

a) A site need not be restored prior to the end of the period authorized for the water use or deposit of waste without a licence, as required by Item 5, if the Board issues a licence for the use of water or deposit of waste on that site prior to the end of that period.

b) An applicant need not submit the report referred to in Item 6 (c), to the Board if the applicant obtains the Board's approval for a use of water or deposit of waste without a licence, or a licence for a use of water or deposit of waste, on the same site within thirty (30) days after the last day of the period authorized for the use or deposit.
