Good afternoon Beniot,

I have recently been assigned the file for the application by the GSC/GOC for the North Baffin Bedrock Mapping project. Could you please provide clarification of the following:

Section 8 of your application form to the Nunavut Water Board for Approval for the Use of Waters and Deposit of Waste Without a Licence, for the North Baffin Bedrock Mapping (Steensby-Barnes) Project includes the burial of waste (i.e. ash) in pits. Schedule 3 of the Nunavut Waters Regulations (SOR/2013-69) lists sewage as the only permitted waste deposit for an Approval Without a Licence. Any other type of waste deposit requires a Type B Licence.

In addition, section 13 of the application form does not list the disposal/deposit of ash.

Typical approval conditions for an Approval Without a Licence for your type of activity would be as follows:

ONE (1) CUBIC METRE PER DAY WATER USE AND ONE (1) CUBIC METRE PER DAY SEWAGE DEPOSIT. ALL OTHER WASTE SHALL BE BACKHAULED TO AN APPROVED FACILITY FOR DISPOSAL

Please let the Nunavut Water Board know if you intend to backhaul all waste (combustible and non-combustible), other than sewage as permitted under the Regulations, or if you'd prefer to begin a Type B Licence application process.
