Hi Cynthia – I just wanted to make a correction to our two water board applications (Cabin Construction in 1. Foxe Basin and 2. Hudson Strait):

The volume of water being disposed of (sewage/grey water) at both site will not exceed the amount consumed (0.05m³/day), as we only will consume water for drinking, cooking and washing dishes, and only dispose of water through those activities.
