Note: As required by recent changes to Articles 11 and 13 of the Agreement Between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada (Nunavut Agreement), all project proposals requiring an application to the NWB, such as this, must be submitted to the Nunavut Planning Commission (the Commission) for their consideration and processing under the NLCA before the NWB can approve an application. The NWB advises that if you have not already done so, please get in touch with the Commission directly to submit a project proposal and forward the Commission's determination and any associated recommendations to the NWB when received. While the NWB awaits the Commission's direction, the NWB will continue to review the application for completeness and you will be notified in due course of any deficiencies. Once the application is considered complete, the NWB will forward the file to the technical department for review and upon receiving confirmation that the Commission's process is concluded the Board may issue a one year approval.
