**RE: NPC File # 149686 [Impacts of Climate Change on Permafrost, Ice, and Hydrology in the Canadian high Arctic]**

The following works and activities have been proposed in the above-noted project proposal:

1. Scientific Research: Ongoing research project. Study the impact of climate change on polar landscapes with a focus on permafrost, ground ice, glaciers, and groundwater.
2. Summary of Modifications: Updated operations phase dates and associated documents.
3. Associated NPC File No: 148330, 148555 and 148822.
4. NIRB File # 07YN019.
5. Location: North Baffin Region [Axel Heiberg Island, North of the community of Grise Fiord]

The Nunavut Planning Commission (NPC) has completed its review of the above noted project proposal. The NPC previously reviewed works and activities associated with the current proposal (conformity determination issued January 18, 2013, July 21, 2016, April 24, 2017, and April 20, 2018, which still applies. In addition, associated activities were previously screened by the Nunavut Impact Review Board, including observation, topographic GPS surveys, shallow permafrost GPR surveys, ground and air temperature measurements, as well as assessments of ground ice, vegetation, glacier ice, and groundwater activity (NIRB FILE NO.: 07YN019). It conforms to the North Baffin Regional Land Use Plan (NBRLUP). The proponent has undertaken to comply with the applicable conformity requirements of Appendix C, H, and I of the NBRLUP.

This project proposal is exempt from the *Nunavut Planning and Project Assessment Act* (NUPPAA) under section 235 of that Act. The above-noted project proposal is exempt from screening by the NIRB because the NPC is of the understanding that the change in operations phase dates does not change the general scope of the original and previously amended project activities, and the exceptions noted in Section 12.4.3 (a) and (b) of the Nunavut Agreement do not apply.

By way of this letter, the NPC is forwarding the project proposal to the regulatory authorities identified by the proponent. Project materials, including the applicable conformity requirements, are available at the following address:
