## 8WLC-MPP2021 – Summary Report for the Use of Waters and Deposit of Waste Without a Licence

Approval for the Use of Waters and Deposit of Waste Without a Licence was received in 2020 for the Morin Point archaeology project (8WLC-MPP2021). Archaeology permits were cancelled last year due to the pandemic. Fieldwork for the Morin Point project has been deferred until this year. I have received confirmation from the Nunavut Planning Commission (NPC) that relevant requirements have been satisfied for 2021. I will apply for a new Approval prior to the expiry of the current authorization (April 28, 2021).
