I am contacting you regarding the Application for the renewal of Water Licence 3BC-NET0913

The Application was sent out for review by stakeholders in a 30 days review period. During the mentioned period NPC did not submit a Conformity Decision.

The NWB has on its ftp site a Nunavut Planning Commission Conformity review, dated June 2009. This NPCCR does not match the project location; though Nettilling Lake appears in the subject of the correspondence, the conformity was determined with regards to the Keewatin Regional Land Use Plan and the project location is in the Qikiqtani Region. I have attached the document to this email.

In order to proceed with the issuance of the WL the Board requires a new / corrected NPC Conformity Decision. Could you please help with this?
