**RE: Water License Inspection CWS Bird Banding Project – Nikku Island Camp July 25, 2009**

The following inspection report is generated on the information collected during a compliance inspection carried out on the Nikko Island Camp located at Latitude: 66° 35' 54"N Longitude: 71° 30' 91"W in the Qikiqtani Region. The inspection was conducted to determine compliance with the terms and conditions of the Water License (3BC-NET0913) issued to Canadian Wildlife Service Environment Canada by the Nunavut Water Board (NWB).

The report references the applicable parts of the Water License (3BC-NET0913) and the findings observed under each of those parts. During the writing of this report a compliance review was undertaken of the documents, plans and manuals filed by the Licensee and located on the Nunavut Water Board's FTP site.

It is to be noted that a representative of the Canadian Wildlife Service was not present during the inspection.

**Issues noted in previous Inspections;**

- Camp was previously unlicensed.
- Camp did not have an incinerator installed but were practicing Open Burning in barrels on site.
- Historic waste and garbage remains on site.
- No secondary containment was present on site.
- Fuel belonging to outside agents was present in the cache of fuel.
- Water usage was not recorded.

**During the period of the 2009 inspection the following issues were identified by the Inspector;**

- An incinerator was not present on site.
- None of the required work to consolidate waste and garbage on site had been undertaken by the licensee.
- No secondary containment was noted on site.

It is noted that the Camp was not occupied at the time of the Inspection



**Non-Compliance:** Issues identified during the July 25<sup>th</sup> 2009 inspection and/or review of relevant material

**Issues with a known or anticipated human health impacts;**

- Open burning of wastes containing hazardous materials was noted at the on site. ( Paint cans and oil cans noted within the Burn barrel)

**Issues where there is a known or anticipated environmental impairment;**

- Historic bulk wastes are not segregated and progressive reclamation work does not appear to be on-going.
- An incinerator was not noted on site.

**Issues where there is a known or suspected violation of a requirement of the Water License or Act;**

- A License was recently issued to the Canadian Wildlife Service. The items noted above may be addressed in the submission of the 2009 annual report due by March 31<sup>st</sup> 2010.
- The above will be reviewed at that time.
