RE: NPC File # 149738 [Shorebird Research - East Bay, Ikkattuaq, and Prince Charles Island]

The following works and activities have been proposed in the above-noted project proposal:

- 1. Continue regular shorebird research at East Bay and Prince Charles Island.
- 2. Modifications to the original/amended project proposal: Conduct non-invasive shorebird research in Ikkattuaq (Harry Gibbons) Migratory Bird Sanctuary in addition to continuing regular shorebird research at East Bay and Prince Charles Island:
 - The Ikkattuaq surveys will be conducted as day trips from Coral Harbour by helicopter between June 20 and June 30, and do not require establishment of a field camp.
 - The shorebird surveys are being conducted in partnership with the Irniurviit ACMC and addresses priority objectives for Ikkattuag MBS outlined in the ACMC Management Plan.

- Extension of the Project Period for 10 years.
- 3. Associated NPC File Nos: 148462, 149041; Related NIRB File No: 06AN026, 05AN011 and 17AN040
- 4. Location: Kivalliq Region; [Ikkattuaq (Harry Gibbons) Migratory Bird Sanctuary]

A complete description of the project proposal reviewed by the Nunavut Planning Commission (NPC) can be accessed online using the link below.

The NPC has completed its review of the above noted project proposal. The NPC previously reviewed works and activities associated with the current project proposal and decision was issued on March 14, 2006, April 23, 2014, February 20, 2017 and February 13, 2019. This conformity determination still applies. In addition, associated activities were previously screened by the Nunavut Impact Review Board (NIRB File Nos.: 06AN026, 05AN011, AND 17AN040).

This project proposal is exempt from the *Nunavut Planning and Project Assessment Act* (NUPPAA) under section 235 of that Act. The above-noted project proposal is exempt from screening by the NIRB because the NPC is of the understanding that the inclusion of non-invasive shorebird research in the Ikkattuaq (Harry Gibbons) Migratory Bird Sanctuary does not change the general scope of the original or previously amended project activities, and the exceptions noted in Section 12.4.3 (a) and (b) of the Nunavut Agreement do not apply.

By way of this letter, the NPC is forwarding the project proposal to the regulatory authorities identified by the proponent.
