Re: <u>Extension Request for NIRB Screening of Environment and Climate Change</u>
Canada's "Shorebird Research-Prince Charles Island" Project Proposal

Dear Ms. McKenna:

On February 20, 2017 the Nunavut Impact Review Board (NIRB or Board) received Environment and Climate Change Canada's (ECCC) "Shorebird Research–Prince Charles Island" project proposal from the Nunavut Planning Commission for screening, pursuant to Part 3 of the *Nunavut Planning and Project Assessment Act* (NuPPAA). Pursuant to subsection 92(4) of the NuPPAA, the NIRB hereby requests that the responsible Minister(s) extend the period for the submission of the Board's written report for the screening of this project proposal, NIRB File No. 17AN040.

Following a preliminary completeness check, the NIRB determined that the proposal as submitted did not contain the necessary information for the NIRB to carry out its screening; therefore on March 3, 2017 the Board requested that the Proponent provide additional information. On March 21, 2017 the NIRB received the required information and commenced the screening pursuant to Part 3 of the NuPPAA. On March 28, 2017 the NIRB distributed notice of the project proposal to potentially affected communities and interested parties with a request for comments to be submitted for the Board's consideration by April 10, 2017. Due to the high volume of screenings currently before the Board and limited availability resulting from continued board member vacancies, additional time is required to complete the decision-making for this file.

The Board requires additional time to fully consider the project proposal and to complete the screening. All documents received and pertaining to the NIRB's screening of this project proposal can be accessed from the NIRB's online public registry at www.nirb.ca by using any of the following search criteria:
