We have a camp at Pellatt Lk, Nunavut (also known as Esker Lodge) that has been there for quite some time but we do not have a water license. The camp if you are not familiar with is in the Kitikmeot Region.

I see some things have changed in the licensing process so to be sure in what needs to be done can you please tell me what steps are needed.

The camp accommodates up to 20 people and is used seasonally for tourism (hunting in the spring and fall) as well as we sometimes host exploration companies at various times of the year.
