Enclosed is the Nunavut Impact Review Board (NIRB) Screening Decision Report to the Honourable Bernard Valcourt, Minister of Aboriginal Affairs and Northern Development and P.J. Akeegok, President for Qikiqtani Inuit Association for Arctic Kingdom's "Pristine Seas Film Project" in the Qikiqtani Region.
