### TO CONDUCT THE FOLLOWING STUDY:

The beginning of an Era: characterizing the depositional environment of Earth's earliest eukaryotic life

### SUMMARY OF RESEARCH:

The license holder proposes to do geological field-work for scientific purposes between July 18

- August 12, 2016 on the Belcher Islands. The specific project aims are to characterize ocean and atmospheric chemistry across an approximately 400 million year interval. This will be achieved through geological mapping, which will be carried out on satellite imagery, and surface sampling (no digging) at 7 fieldcamp locations (all on Inuit owned lands) for subsequent geochemical analyses at McGill University.
