I would suggest that initially you provide our office with your project proposal. If your water use is below the threshold you would only require a yearly "approval without a licence" which would have to be applied for on a yearly basis. If you will be using over 50 m3/day of water you would need a Type B licence. Attached for your reference is the application for approval without a licence as well as the Type B application and a few of our Guides. Please use the one that best fits your proposal. The technical department will take a look at your submissions and make the final determination on what type of licence you require. The more information you can provide the better it will be for the NWB to determine what type of water licence you will require.

Hi Phyllis, I found your contact info on line. I am representing a group of investors who were recently granted a permit to construct a brewery in Iqaluit. As part of our business plan we are exploring the possibility of using the water from the Sylvia Grinnell River in Iqaluit as a source of water for products.

As I read online, a license is not required if the useage is less than 50m3 of water per day. However there are certain information that will need to be provided in order for the NWB to consider the application.

At this time we envision using about 3m3 of water per day on average. The river would be accessed by truck and the water pumped into storage tanks for removal to the brewery, perhaps once or twice a month.

Can you tell me how we go about formally making the application and what information will need to be provided.

We are in no rush for this but thought we could at least determine what is required on our end.
