Subject: Response to Upcoming Meeting – Industry Expectations

Dear Spencer, Andrew and Bill,

Thank you for your May 2, 2025 letter regarding the upcoming meeting. With only a week remaining, we appreciate the communication and the engagement from your departments, particularly from those working in policy.

Over the past several days, we have been in conversations with our members and are aware of strong interest and commitment from producers, advancing projects and explorers to be represented at the meeting, both physically and virtually. Their presence underscores the importance of this dialogue for industry and its future in the North.

Noting that an agenda was not included in your letter, we would like to highlight some expectations from industry to support meaningful participation and constructive dialogue while noting the caretaker provisions for the federal government are in place to May 16, 2025 (please clarify if there is a different date). We would ask that arrangements include the following:

Proper audiovisual (AV) support for virtual attendees, including:

- Reliable internet connection with sufficient bandwidth
- Functioning microphones and speakers in the meeting space
- Dual screen sharing capability (for slides and participants)
- Clear video feed of presenters and panelists
- Confirmation of Yellowknife venue for the meeting
