Industry and Public Stakeholders – Via uploads to both the Northwest Territories Online Review System and Nunavut Water Board Public Registry

Re: Crown-Indigenous Relations and Northern Affairs Canada's (CIRNAC) and Government of Northwest Territories' (GNWT) summary of feedback received by May 30, 2025, revised RECLAIM 8.0 tool and associated User Manual, and invitation for further engagement

Dear Parties,

Background

Crown-Indigenous Relations and Northern Affairs Canada (CIRNAC) is currently undertaking an update of the RECLAIM 7.0 Model (update to RECLAIM 8.0) and associated User Manual. The Government of the Northwest Territories (GNWT) is collaborating with CIRNAC on this update, as it is the current version also used in the NWT. The purpose of the update is to more accurately reflect the actual costs and site specific activities as they relate to environmental liability estimates.

On January 23, 2025, an in-person and virtual engagement session, including a presentation on the potential updates to RECLAIM 8.0, was held in Vancouver at the Association for Mineral Exploration Conference. Working copies of the RECLAIM 8.0 Model, associated User Manual, and a summary report highlighting proposed changes, including rationale, were uploaded to both the Northwest Territories Online Review System and Nunavut Water Board Public Registry for public review on that date.

RECLAIM 8.0 public engagement and commenting periods

Nineteen written submissions, totaling 203 comments, were received by CIRNAC and the GNWT by the March 31, 2025 RECLAIM 8.0 public engagement and commenting period deadline. Comments pertained to the general themes of unit rates, policy, indirects, user manual, net present value, and contingency. CIRNAC and the GNWT heard in the January



23, 2025 engagement session the usefulness to hear other's public feedback and have the opportunity to augment their public feedback accordingly. CIRNAC and the GNWT summarized the first written feedback received in the first RECLAIM 8.0 public engagement and commenting period by April 9, 2025 and posted it on both public online review systems for further feedback. By May 30, 2025, CIRNAC and the GNWT received 4 additional written submissions, totalling 112 additional comments. These comments pertain to the general themes of unit rates, policy, user manual, and net present value.

The second summary of written feedback including responses from CIRNAC and the GNWT, revised working copies of the RECLAIM 8.0 Model, associated User Manual, and a summary report highlighting June 16, 2025 proposed changes (Appendix A) including rationale, were uploaded to both the Northwest Territories Online Review System and Nunavut Water Board Public Registry for public review on that date. CIRNAC and the GNWT request further public feedback on the update to RECLAIM 8.0 and the associated User Manual be submitted by August 15, 2025 via the Northwest Territories Online Review System or Nunavut Water Board Public Registry. Written feedback received by August 15, 2025 will inform the October 6 – 10, 2025 workshop agenda.


Further in-person engagement on the updates to RECLAIM 8.0 and associated User Manual

CIRNAC and the GNWT committed to two additional in-person and virtual engagement sessions, including one in Iqaluit, Nunavut, and one in Yellowknife, NWT. The 2025 Nunavut Mining Symposium is hosted by the Nunavut Mining Society in Igaluit, Nunavut from April 7 - 10, 2025. CIRNAC presented a summary of the public feedback received to both online review systems thus far. CIRNAC also had one-on-one meetings to further engage on the RECLAIM update. The GNWT, with CIRNAC, hosted a one day RECLAIM update workshop in Yellowknife, NWT on May 14, 2025. One-on-one meetings were also held to further engage on the update during the week of May 12 – 16, 2025, in Yellowknife, NWT.

CIRNAC and the GNWT received requests for continued engagement in a workshop format on topics such as Unit Rates, Direct and Indirect costs, and the User Manual. In consultation with stakeholders, the 5 consecutive days of October 6 – 10, 2025 were selected (location to be determined) for CIRNAC and the GNWT to host the workshop. The agenda for the workshop will be based on the public written feedback received by August 15, 2025.

Conclusion

CIRNAC and the GNWT would like to thank all who have engaged in and/or provided feedback on the RECLAIM tool update thus far. As always, our door remains open to productive engagement and new or innovative ideas in the shaping of the RECLAIM tool. Appendix A: Summary report highlighting June 16, 2025 proposed changes to RECLAIM 8.0 and associated User Manual

The RECLAIM Model is a financial tool used in the Northwest Territories and Nunavut to estimate the environmental liability cost of mine closure and reclamation if a mine were to become abandoned or defaults into government or land owner care. The posted financial security for mines is a separate process that is informed by the RECLAIM Model and the policy of the applicable jurisdiction.

The intent of the RECLAIM Model is to:


- Ensure adequate closure cost estimating so the public are not left with cleanup costs.
- Have a standardized approach allowing for fair and consistent cost estimates.
- Account for long-term liabilities, such as water treatment and tailings stabilization.

CIRNAC and the GNWT commissioned Brodie Consulting Ltd. and AtkinsRéalis to conduct a review of stakeholder feedback and assess for additional changes to the RECLAIM v 8.0 (working draft). A summary of changes made to the June 16, 2025 RECLAIM Model following stakeholder engagement is summarized in the table below.

4	Default of only 2 years of ICM is insufficient and should be set to 5 years.	ICM default duration set to 5 years but can be varied as circumstances dictate as per version 7.	
5	Lack of line items provided for Quarry and Borrow pit development.	Additional items were added under Quarries and Borrows under open pit to include more development and reclamation activities.

11	Maintenance of passive treatment systems other than wetlands not included under Post-Closure Monitoring and Maintenance.	Added additional line items and modified the title to make it clear that maintenance requirements cover any passive treatment system not just constructed wetlands.
12	Need additional line items under Post-Closure to cover maintenance activities related to dams and tailings.	
13	Removed legacy hidden sheets.	Several sheets were hidden and not needed and removed for clarity including "UR-Short list_New" and "Monitoring Template".
14		The formula reference to the manual CPI entry was not locked resulting in it referencing the wrong cell. The formula was corrected to reference the correct cell



	and the reference was locked to avoid future issues.
Added in additional table for tailings water treatment.	Both Tailings and Water Management tabs refererenced the same cell under Water Treatment. An additional table was created under Water Treatment so the tabs could reference separate tables and avoid any potential duplication.

Conclusion

Based on feedback from stakeholders revisions were made to the working copy of RECLAIM V8, primarily related to indirect percentages and additional clarification on maintenance items. Some additional discussion was identified to clarify application of some of the indirect percentages within RECLAIM and how these can be integrated into the tool or included as a separate item. Outstanding public written feedback comments from the March 2025 and May 2025 commenting periods, and upcoming August 15, 2025 commenting period deadline, will be reviewed and considered for inclusion in the RECLAIM Model. The results and feedback from the October 6-10, 2025 workshop will also be considered for inclusion in the final version of RECLAIM 8.0.
